WE HOSTED OVER 150 VOLUNTEERS, WHO PARTICIPATED IN COMMUNITY BUILDING FOR ALMOST 7000 HOURS. VOLUNTEERS AND STAFF COMBINED EFFORTS TO PRODUCE THREE ORIGINAL EXHIBITIONS: "SILICON VALLEY EATS" ABOUT THE TRANSITION OF THE AREA FROM AGRICULTURAL PRODUCTION TO SUBURBAN RESTAURANT CONSUMPTION THROUGH TO MODERN INNOVATION; "OUR COMMUNITY PREPARES" ABOUT EMERGENCY PREPAREDNESS IN RECOGNITION OF THE 30TH ANNIVERSARY OF THE LOMA PRIETA EARTHQUAKE, AND "GALLERY 9", CELEBRATING THE 50TH ANNIVERSARY OF A LOCAL ART GALLERY. AFTER THE COVID 19 PANDEMIC HEALTH PRECAUTIONS CLOSED DOWN PUBLIC VISITATION TO THE MUSEUM, WE SWITCHED TO ONLINE EXHIBITIONS, AND UNVEILED "FROM THE FIELDS OF THE NORTH/EN LOS CAMPOS

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$) SPECIAL EVENTS SUCH AS LECTURES, SPECIAL TOURS, OPENING RECEPTIONS FOR EXHIBITIONS, AND CLASSES, WERE CURTAILED IN THE LATTER HALF OF FY 2019-2020 BECAUSE OF THE COVID-19 PANDEMIC. WE WERE HOWEVER GRATEFUL TO HAVE HOSTED COMMUNITY CELEBRATIONS FROM JULY 2019 UNTIL FEBRUARY OF 2020 THAT INCLUDED OUR SUMMER VOLUNTEER APPRECIATION BARBEQUE AND OUR HOLIDAY BOUTIQUE AND CONCERT, WITH OVER 150 ATTENDEES EACH, AND EXTERNAL RENTALS FOR WEDDINGS AND MEMORIAL THAT BROUGHT OVER 3,000 PEOPLE TO THE MUSEUM. BOTH OF OUR LARGE FAMILY-FRIENDLY FESTIVALS WERE CANCELED, BUT WE DID BRING COMMUNITY ENRICHMENT AND EDUCATION IN THE FORM OF AN "ESCAPE HOUSE" ADVENTURE IN THE HISTORIC J. GILBERT SMITH HOUSE, AND WE FACILITATED COMMUNITY RECOGNITION OF A FOUNDATIONAL CHINESE INSTITUTION IN LOS ALTOS THAT BROUGHT IN OVER 150 PEOPLE.

IN THE SUMMER OF 2019, WE INITIATED A TEEN DOCENT PROGRAM, BRINGING 15 HIGH SCHOOL STUDENTS FOR A TWO-WEEK LONG TRAINING SESSION ON OUR LOCAL HISTORY THAT PREPARED THEM TO BECOME DOCENTS. OUR POPULAR THIRD AND FOURTH GRADE TOURS WERE CANCELED IN FY 19-20 BECAUSE OF THE COVID-19 PANDEMIC, BUT WE DID HAVE 244 THIRD-SIXTH GRADERS PARTICIPATE IN OUR HISTORY ESSAY CONTEST, ON THE TOPIC OF PHOTOGRAPHS OF OUR ANCESTORS. WE HELD EDUCATIONAL LECTURES TIED TO OUR EXHIBITIONS BOTH IN PERSON AND ONLINE, INCLUDING A SERIES OF WORKSHOPS ON EMERGENCY PREPAREDNESS.
