LOS ALTOS HISTORY MUSEUM OPENED A MAJOR NEW PERMANENT EXHIBITION ON FEBRUARY 9, 2023. THIS PROJECT WAS THE CULMINATION OF THREE YEARS OF EXTENSIVE EFFORT FROM THE STAFF, VOLUNTEERS, AND COMMUNITY DONORS. IN ADDITION, DURING FY 2022/2023, WE MOUNTED SIX CHANGING EXHIBITIONS. THE SIGNATURE EXHIBITION DURING THIS PERIOD WAS WALLACE STEGNER: PATHWAY TO CONSERVATION, WHICH FOCUSED ON THE ICONIC AUTHOR OF WESTERN AMERICAN LITERATURE WHO LIVED IN LOS ALTOS HILLS AND ESPOUSED A DEEP CONCERN WITH DWINDLING RESOURCES. IT WAS AN OUTDOOR EXHIBIT ON DISPLAY FROM OCTOBER 2022 TO MARCH 2023 THAT INCLUDED A KID-FRIENDLY SCAVENGER HUNT. IN THE J. GILBERT SMITH HOUSE, WE FOCUSED ON YOUTH WITH AN ART EXHIBITION FEATURING WINNING SUBMISSIONS FROM A COUNTY-WIDE YOUTH ART

LOS ALTOS HISTORY MUSEUM PROCESSED 140 DONATIONS OF ITEMS DURING THIS FISCAL YEAR, INCLUDING ADDING ITEMS TO OUR LIBRARY, PHOTOGRAPHY COLLECTION, AND 3-D ARTIFACT COLLECTION. WE SCANNED A LARGE COLLECTION OF COLOR SLIDES FROM THE 1930S AND 1940S AS WELL AS MANY OF OUR MAPS. WE ADDED PHOTOGRAPHS OF OVER 100 ITEMS TO OUR DATABASE, IN PREPARATION FOR MAKING THE DATABASE SEARCHABLE FOR THE PUBLIC. WE ALSO PREPARED ORAL HISTORIES FOR PUBLICATION ON OUR WEBSITE BY CREATING INDEXES, ABSTRACTS, AND SEARCH TERMS, AS WELL AS REVIEWING ALL OF OUR EXISTING 200 ORAL HISTORIES.

LOS ALTOS HISTORY MUSEUM OFFERED FOUR FAMILY-FRIENDLY FESTIVALS THIS YEAR, DRAWN FROM THE FOUR SECTIONS OF THE PERMANENT EXHIBITION: HILLS, VALLEY, TOWN AND CREEKS. IN MAY OF 2022, WE HELD RANCHO DAY: HORSEMANSHIP OF THE HILLS FEATURING OUR FRIENDS FROM THE LOS ALTOS HILLS HORSEMEN'S ASSOCIATION AND TALENTED PERFORMANCES BY FOLKLORICO DANCERS. IN EARLY JULY, 2022, THE APRICOT STEM FAIR HAD A THEME OF "A TALE OF TWO VALLEYS" AS WE GAVE VISITORS PEAKS INTO THE EXPERIENCE OF BOTH THE VALLEY OF HEARTS DELIGHT AND SILICON VALLEY.
